The Parliament shall, subject to this Constitution, have power to make laws with respect to matters relating to the Aboriginal and Torres Strait Islander Voice, including its composition, functions, powers and procedures.”

Q2. There will be a referendum about establishing a Voice to Parliament for Aboriginal and Torres Strait Islander people.

It will read: “A Proposed Law: to alter the Constitution to recognise the First Peoples of Australia by establishing an Aboriginal and Torres Strait Islander Voice.”

It is compulsory for Australian citizens to vote “yes” or “no” in a referendum.
