III- Cases Where the Right to Apply Cannot Be Exercised

In the following cases, it is not possible to exercise the right to apply:

- The processing of personal data for purposes such as research, planning, and statistics by making it anonymous with official statistics.
- Provided that personal data do not violate national defense, national security, public security, public order, economic security, privacy, or personal rights, or do not constitute a crime, it may be processed for artistic, historical, literary, or scientific purposes, or within the scope of freedom of expression.
- The processing of personal data within the scope of preventive, protective, and intelligence activities carried out by public institutions and organizations that are assigned duties and powers by law to ensure national defense, national security, public security, public order, or economic security.
- The processing of personal data by judicial authorities or enforcement agencies in relation to investigation, prosecution, judicial proceedings or execution of sentences.

The right to apply cannot be exercised except for the right to request compensation in the following cases.

- The necessity of processing personal data for the prevention of crime or for criminal investigation.

- The processing of personal data that has been publicized by the data subject.

- In responses provided in non-written formats such as CD or flash drives, the fee that may be charged is determined not to exceed the cost of the recording medium used.
- If it is understood that the application was due to an error by Ipsos Turkey, the

fee received from the Data Subject will be refunded under this article.

V- Responding to Your Applications

Your applications will be duly responded to in writing at the address you provided for notification, or via an email to the email address you provided.

Requests included in your application will be concluded as soon as possible according to their <u>nature and at the latest</u> within 30 (thirty) days from the date your application is received by us.

VI- About the Application Form

The application form below has been prepared entirely to help you to carry out your applications in accordance with the Personal Data Protection Law No. 6698 (KVKK), correctly and fully, and to provide convenience to you.
