

3. The Quebec National Assembly recently passed Bill 62, which is meant to establish measures to foster adherence to State religious neutrality. Under the bill, personnel members of public bodies and of certain other bodies must exercise their functions with their face uncovered, unless they have to cover their face, in particular because of their working conditions or because of occupational or task-related requirements. In addition, persons receiving services from such personnel members must have their face uncovered.
