

Quality Control Measures

IPSOS EMPLOYS QUALITY CONTROL MEASURES TO ENSURE THE HIGHEST POSSIBLE INTEGRITY OF OBTAINED RESULTS/DATA

- For at least 15% of the interviews, a supervisor is present throughout
- Field managers visit at least 15% of the respondents in the sample at their households to confirm the interviews (i.e. back-checking).
- After the interview data are electronically transmitted to the Ipsos server: an independent team then makes random phone calls to 20% of the respondents to confirm that the interviews were conducted with the said respondents (i.e., telephonic back-checks).
- Mobile data collection platform captures GPS location (latitudes and longitudes) of interviews conducted to verify the locations of the interviewers in the field alongside allowing silent recording.
- Logical data checks are made on selected questionnaire entries to ensure conformity with the flow of the questions answered by the respondents.
- Sample quotas were monitored to match the sample's statistical parameters.






RESPONDENTS' DEMOGRAPHIC PROFILE

(**Weighted for:** Gender, Age, Region and Setting)






Main Cash-Crop: by The 23% Whose Main Source of Household Ipsos Public Affairs Income is Agriculture







Main Source of Self Employment








Main Source of Money (of the 57% Who Report Having Earned Any)




Estimated Monthly Household Income: by Total, Supporters of the Main Political Parties/Coalitions




Estimated Monthly Household Income: by (Respondent's) Level of Education




Fieldwork for this survey was conducted between 4th and 12th March, 2018. During and after that time several developments occurred whose (full) impact may not be reflected in some of the results reported in this survey. Among them are:

- On-going investigation into the surgery at KNH/KNH CEO Lily Koros sent on compulsory leave" by CS Sicily Kariuki (2-8 March)
- CS Henry Rotich issues budget warning/proposed reduction allocation to counties (7 March)
- Meeting between President Kenyatta and NASA leader Raila Odinga at Harambee House followed by public remarks expressing their joint commitment to national unity based upon such further joint discussions (9 March)
- US Sec. of State Rex Tillerson visits Kenya hours after the Uhuru-Raila 'handshake' (10-11 March)



Recent Events Not (Fully) Captured (con't): Ipsos Public Affairs



- NASA leaders' meeting to discuss unity/"the way forward" after 'hand-shake' fall-out (12 March)
- Environment CS Keriako Tobiko orders the sacking of Kenya Forest Service officers at several stations for criminal negligence regarding protection of forest areas and suspends KFS head Emilio Mugo (11, 13 March)
- Massive flooding in Nairobi and various other parts of the country (especially from 14 March)
- Kalonzo Musyoka says he and the other two NASA principals also want to meet Uhuru for talks (14 March)
- Senator Moses Wetang'ula of Ford-Kenya replaced by Senator James Orengo of ODM as Senate Minority Leader (15 March)

- Three NASA Principals meet without Raila to discuss the future of NASA, while Raila explains that "it was not easy" for him to agree to meet Uhuru, but there was a "need" for the two of them to talk (16 March)
- Kenyatta National Hospital Board confirms the suspension of CEO Lily Koros (16 March)
- Attending a campaign rally in Kitui, the three other NASA Princiapls declare they are prepared to constitute the Official Opposition in parliament if ODM aligns itself with Jubilee (19 March)
- Raila holds public meetings in Nyanza to prepare for joint tours with Uhuru;
 various FORD-Kenya leaders advise ODM to quit NASA and leave it along with
 Wiper and ANC to constitute the official Opposition (19 March)
- Ford-Kenya Senator Moses Wetang'ula replaced as Minority Leader by Senator James Orengo (20 March)
- Raila meets US Ambassador R. Godec for consultations in his Upper Hill office (21 March)



Recent Events Not (Fully) Captured (con't): Ipsos Public Affairs

- Raila says NASA leaders will give their senators "two weeks" to reinstate Sen. Wetang'ula as Minority Leader (22 March)
- In a media interview, ANC leader/NASA Principal M. Mudavadi claims Raila betrayed not just the other NASA leaders but the 'NASA dream' itself (23 March)
- ODM announces intention to create a new party position to oversee implementation of the Uhuru-Raila 'unity pact' (24 March)
- FORD-Kenya Senator Moses Wetang'ula declares he will not seek reinstatement as Senate Minority later (25 March)
- NASA Principal Kalonzo Musyoka suggests that NASA be registered as a political party (25 March)
- Lawyer Miguna Miguna returns to Kenya but is prevented from leaving JKIA on the grounds that he failed to produce required travel documents (26 March)



Recent Events Not (Fully) Captured (con't): Ipsos Public Affairs

- Activist 'NRM' lawyer Miguna Miguna arrives in Kenya from Canada but is unable to pass through Immigration (26 March)
- Despite several phone calls (to one or more undisclosed people/offices), Raila fails to effect Miguna's exit from JKIA and official entry into Kenya (27 March)
- Miguna's lawyers prevented from accessing him at the airport, after which he is put on a flight to Dubai after allegedly being drugged (28 March)
- Several FORD-Kenya and ANC MPs advocate the merger of their two parties, claiming ODM has now "left NASA" (29 March)
- After two days in the custody of airport officials, Dubai returns Miguna to Canada (2 April)
- Wiper party meets to discuss its solo future as 'One Kenya Movement" (2 April)





Recent Events Not (Fully) Captured (con't):

- CS for Internal Security F. Matiang'i accuses a small "clique" of judges, lawyers and civil society activists of attempting to frustrate the government through litigation he described as spurious (3 April)
- International conference on universal health care held in Msambweni, Kwale, including an appearance by President Kenyatta (4-5 April)
- Odinga makes his first anti-government comment (in a press statement) since his 'hand-shake' with Uhuru in strongly criticizing CS
 F. Matiangi' for both attacking the independence of the Judiciary and undermining his 'reconciliation' with the president (4 April)
- Jubilee government reportedly prepared to recommend Odinga's appointment by the AU as a peace-conflict ambassador (5 April)
- CJ David Maraga refutes CS Matiangi's claim that a section of the Judiciary has been "captured" by anti-government "activists" and advises those unhappy with court rulings to lodge appeals (5 April)





"What is the main area that you would like your new County government to improve?" (Single Response –Unprompted): by Total




"Do you think that medical/health services should mainly be the responsibility of the county or the national government?": by Total, Supporters of the Main Political Parties/Coalitions

by Total, Region




























