#### Methodology

This third wave of the 538 Impeachment/Ipsos Poll was conducted December 13<sup>th</sup> to December 16<sup>th</sup>, 2019 using Ipsos' KnowledgePanel®. The first wave of this poll was based on a nationallyrepresentative probability-based sample of 2,088 adults age 18 or older and included a general population sample of US adults as well as an oversample of Independents and those with no party preference to ensure a sufficient sample size among them. Wave 2 was fielded to all who completed wave 1 and had 1,726 completes. Wave 3 was also fielded to all who completed Wave 1 and had 1,588 completes. The study weights, as described in further detail below, adjusted for the oversample using party identification benchmarks from ABC News so that results reflect the general population of US adults.

The survey was conducted using KnowledgePanel, the largest and most well-established probabilitybased online panel that is representative of the adult US population. Our recruitment process employs a scientifically developed addressed-based sampling methodology using the latest Delivery Sequence File of the USPS – a database with full coverage of delivery points in the US. Households are randomly sampled and all persons in the selected households are invited to join and participate in the panel. Ipsos provides selected households who do not already have internet access with a tablet and internet connection at no cost to the panel member. Those who join the panel and who are selected to participate in a survey are sent a unique password-protected log-in used to complete surveys online. As a result of our recruitment and sampling methods, samples from KnowledgePanel cover all households regardless of their phone or internet status and findings can be reported with a margin of sampling error and projected to the general population.

The study was conducted in both English and Spanish. The data were weighted to adjust for gender by age, race, education, Census region, metropolitan status, and household income. The demographic benchmarks came from the 2019 March supplement of the U.S. Census Bureau's Current Population Survey (CPS). Due to the oversampling of Independents and those with no party preference, the data were also weighted to adjust for party identification. Party ID benchmarks are from recent ABC News/Washington Post telephone polls. The weighting categories were as follows:

- Gender (Male/Female) by Age (18–29, 30–44, 45–59, and 60+)
- Race/Hispanic Ethnicity (White/Non-Hispanic, Black/Non-Hispanic, Other or 2+ Races/Non-Hispanic, Hispanic)
- Education (Less than High School, High School graduate, Some College, Bachelor and beyond)
- Census Region (Northeast, Midwest, South, West)
- Metropolitan status (Metro, non-Metro)
- Household Income (Under \$25,000, \$25,000-\$49,999, \$50,000-\$74,999, \$75,000-\$99,999, \$100,000-\$149,999, \$150,000+)
- Party ID (Democrat, Republican, Independent, Something else)





The margin of sampling error is plus or minus 2.9 percentage points at the 95% confidence level. The margin of sampling error takes into account the design effect, which was 1.39. The margin of sampling error is higher and varies for results based on sub-samples; it is lower for longitudinal analyses comparing estimates over time. In our reporting of the findings, percentage points are rounded off to the nearest whole number. As a result, percentages in a given table column may total slightly higher or lower than 100%. In questions that permit multiple responses, columns may total substantially more than 100%, depending on the number of different responses offered by each respondent.
