


Ipsos MORI UK Public Attitudes to Britain's exit from the EU



And do you personally know someone whose job or business has been positively or negatively impacted by Britain's exit from the EU?



Regardless of how you voted in the EU referendum, do you believe Britain's exit from the EU is working out better or worse, or about the same as you expected?



Regardless of how you voted in the EU referendum, which two or three, if any, of these do you see as the most **positive** outcomes of Britain leaving the EU?






Regaining control of laws and regulations is the top positive outcome of Brexit for Leave voters

Top five positive outcomes for 2016 Leave voters




Top five positive outcomes for 2016 Remain voters




Loss of freedom of movement is the top negative outcome of Brexit for Remain voters

Top five negative outcomes for 2016 Leave voters




Top five negative outcomes for 2016 Remain voters
