

How closely, if at all, have you been following the story about an alleged Christmas Party at Downing Street in December 2020?



How closely, if at all, have you been following the story about an alleged Christmas Party at Downing Street in December 2020? How closely, if at all, did you follow any news about the Budget?



And where have you seen or heard information about this story? Please select all that apply.



Was there a Christmas Party at Downing Street that broke COVID regulations?



My work has already held an in-person Christmas party and I attended


My work is not holding any in-person Christmas party this year
