Ipsos Reference: Study on attitudes towards same-sex relationships reveals a shift towards greater inclusivity in Singapore

Release Date: 16th June 2022

About the study

 Between 25 May 2022 and 2 June 2022, Ipsos ran a nationally representative online survey of n=500 Singaporean Citizens and Permanent Residents aged 18 and above, in which respondents were asked about their attitudes towards Section 377A and other aspects of same sex-relationships.

Why was this study performed?

- The study comes five years after the first research was released by Ipsos in 2018 to mark the 10th year of Pink Dot SG, a not-for-profit movement organised to raise awareness of, and support for, the lesbian, gay, bisexual, transgender and queer (LGBTQ) community in Singapore.
- Ipsos is a world leader in understanding the perceptions of citizens, public service users and other stakeholders. In this capacity, Ipsos regularly performs self-funded research projects to better understand the social climate in countries across the globe.

Client Commissioning the Research

 This study did not have any external sponsors or partners. It was initiated and run by Ipsos, because we are curious about the world we live in and how citizens around the globe think and feel about their world.



How do you ensure that the sample is representative?

 Our sample of n=500 Citizens and Permanent Residents was representative of the Singapore population in terms of Age, Gender, and Ethnicity, based on the latest Department of Statistics population estimates.

How accurate are the results?

- At 95% confidence, a sample of n=500 has a maximum margin of error of ±5% (based on a Bayesian Credible Interval). This means that, for example, if 50% of our sample indicated that they rode the MRT each week, we could be 95% sure that between 45% and 55% of the population do so.
- Credible intervals are wider among subsets of the population.

Survey Questions covered in this release

Q. Which of the following of the following would you identify as? (Regardless of how you currently present yourself with a different sexual identity)

- Heterosexual / straight (Describes a person who is attracted physically and emotionally to individuals of the opposite sex.)
- Bisexual (Describes a person who is attracted to both men and women.)
- Lesbian / homosexual female (Describes a woman who is attracted, emotionally and/or physically, to other women.)
- Gay / homosexual male (Describes a man who is attracted, emotionally and/or physically, to other men.)
- Asexual (Describes a person who is not sexually attracted others and has no desire to engage in sexual behavior.)
- Pansexual / Omnisexual (Describes a person who is emotionally or physically attracted to — or has the potential to be attracted to — people of any gender or gender identity.)
- Other

- Prefer not to say

Q. Section 377A of the Singapore penal code states that:

"Any male person who, in public or private, commits, or abets the commission of, or procures or attempts to procure the commission by any male person of, any act of gross
