


The public claim to understand council tax, income tax and national insurance most.

Below is a list of different types of tax paid by individuals and businesses in the UK. How much, if at all, would you say you understand about each of the following?



Overall, do you consider the following types of tax paid by individuals and businesses in the UK to be fair or unfair, if either?







If taxes could be cut, the public support cutting income tax for those paid **between £12,570** and £50,000 most



Y axis: Overall, do you consider the following types of tax paid by individuals and businesses in the UK to be fair or unfair, if either? *Net fair




Both 2019 Conservative and Labour voters would prefer to see tax cuts for lower earners most of all as well as council tax. Conservative particularly want to see fuel duty cut



If taxes needed to be increased, the public most support raising them for the highest earners




