


To the best of your knowledge, how often does your child /do your children use the internet including when they may not be at home such as at school/nursery or with other family members?

Smartphones and tablets are the most used devices by children to access the internet.


Which, if any of the following devices does your child / do your children use to access the internet? Please select all that apply for any of your children.

How confident are you that you know what your child is/ children are seeing or hearing online?







Three in four parents are concerned about what children in general are seeing, hearing or doing online.


To what extent, if at all, are you concerned about what children in general are seeing, hearing or doing online?





Parents are most likely to have had discussions about the risks of online activity with their children as a protection measure. Parental controls / restrictions on behaviour are common approaches too.


Which of the following measures, if any, do you take or have you taken to try and protect your child or children online? Please select all that apply.



3 in 4 parents would support schools requiring deposit boxes for phones during lesson time. A majority also support a smartphone ban in schools altogether.


