


## The EU is increasingly seen as Britain's most important trade partner


Which of the following, if any, do you consider to be Britain's most important trade partner today?


Looking ahead five years, the British public are most likely to expect the EU to be Britain's most important trading partner






## Half of Britons now think that a trade deal with the EU should be prioritised over the US, a significant increase since March 2025 and the start of Trump's tariffs


# A majority still think that US tariffs will have negative impacts, but more now think they won't affect their personal finances

No brackets indicates new statement for May 25




As you may know US President Donald Trump has introduced a minimum 10% tariffs on all goods being imported into the United States. A 10% tariff has been applied to all products imported from the UK, but some countries have received higher tariffs, such the European Union and China. He's also applied higher tariffs for all countries on certain products. For example, there's a 25% tariff on all foreign cars imported into the US, including from the UK
