

#### **Assisted Dying Research**

• Fieldwork dates: 5<sup>th</sup> – 19<sup>th</sup> June 2015

• All figures in percentages

• Base: All adults in each country (n = minimum 2000)

- Interviews conducted online among a quota sample of adults in each country
- Data have been weighted to the known offline population profile for each country according to age, gender, region and working status. Additional weighting criteria were applied in some countries and are indicated in the table below.
- An asterisk represents a percentage less than 0.5 but greater than 0
- Numbers may not always add up to 100% due to computer rounding or multiple answers
