Methodology



23,000 online surveys. 23 countries.

- Semi annual study fielded in April & November
- Field Dates: April 14 to May 7, 2009
- N = 1,000 completes per country.
- 95% confidence level, +/- 3.1% margin of error.
- 75% of world's GDP covered:
 - US, Canada, Brazil, Mexico, Argentina, South Korea,
 China, Japan, Australia, Russia, India, Czech
 Republic, Poland, Hungary, Turkey, Sweden,
 Netherlands, Belgium, Germany, France, Italy,
 Spain, and Great Britain.
- Balanced by age, gender, city population, and education levels, with minor added weights applied.

Key Points: Global Agenda



- The global agenda is all about Jobs, Jobs, Jobs.
 - For the first time, a majority of global citizens (53%) cite "Jobs and Employment" as the number one issue.
- The Jobs agenda is "King" in the United States with a majority of American citizens (63%) citing it as the number one issue.
- The economic crisis is close and personal. Indeed, a majority of global citizens (71%) know someone who has lost a job.
- So what should be done?



Key Points: Global Economy



- Government intervention as a solution gets mixed reviews.
- On the one hand, global citizens have their doubts about the effectiveness of "economic stimulus packages" implemented by governments around the world.
 - Indeed, a strong majority of global citizens (66%) believe that "massive government spending" actually indicates a lack of clear direction and grasp of the problem on the part of governments.
- Global citizens also don't see increased government regulation as a panacea. A strong global majority (60%) believe that increased government regulation will stifle economic growth.
 - This opinion is especially strong in the United States and in Emerging Markets.



Key Points: Global Agenda



- On the other hand, even with such criticisms, citizens want more from global economic players. Indeed, only a minority see the European Union, the United States, and China as doing enough to kick start the global economy.
- Fears of economic populism abound, yet populist policy options are still on the table for citizens.
 - A majority of global citizens (63%) worry that other countries will block exports from their own country.
 - However, contrary minded, a global majority (54%) believe that their government should restrict imports












The US Agenda...








Job Losses Are Affecting Countries Across The Board...



% Has personally lost, or knows someone who lost their job in the past 6 months






Job Losses Are Hitting LATAM/BRIC Countries The Hardest...



% Has personally lost, or knows someone who lost their job in the past 6 months









2/3'rds (66%) Don't think Governments Know What They're Doing on Stimulus Spending...







Do you believe that increased government regulation will stifle economic growth?






42% Think <u>US</u> Has Done Enough To Kick Start Global Economy...




In your opinion, has the United States done enough to help kick start the global economy?





47% Think <u>European Union</u> Has Done Enough To Kick Start Global Economy...








32% Think China Has Done Enough To Kick Start Global Economy...



In your opinion, has China done enough to help kick start the global economy?









Are you worried about other countries blocking imports from your country?






Most (54%) think Their Government Should Do More To Restrict Imports...
