Summary of Findings

What Are Workers Wearing in the Workplace? What's the Norm? What's Acceptable or Not? For this Reuters/Ipsos News Poll we interviewed Employees in 24 Countries and got the Wherewithal on the Wear...

Employees In 24 Countries Were Asked About Workplace Wear...

- One quarter (26%) of workers wear a type of uniform on the job... one third (34%) of workers wear business/smart dress on the job... and four in ten (40%) workers wear casual attire on the job...
- Four in ten workers (38%) have an employer that has a day or time specifically set aside for casual wear during the working hours that normally would be otherwise...

A majority (55%) of workers believe that wearing a more prescribed workplace or business attire makes people more productive...

- 45% of workers think someone wearing casual work clothes is more productive in their job than someone wearing a more prescribed workplace or business attire... but 55% of workers believe someone wearing a more prescribed workplace or business attire is more productive in their job than someone wearing casual work clothes...
- Only one quarter (24%) of workers say it's appropriate to wear shorts to work...
- One in five (21%) workers says it's appropriate to wear thong sandals (flip-flops) to work...
- Only four in ten (37%) workers say casual workers in their workplace will never make it into senior management...
- Only one in five (20%) employees think casual dressers in their workplace are "slackers"...


- A majority (56%) say a Speedo/Bikini bathing suit are appropriate wear at an employee beach/picnic function...
- But then again, a majority (56%) of workers believe that wearing a Speedo or bikini is appropriate at an employee beach or picnic function...
- Two thirds (66%) of workers say senior managers that run an organization should always be more dressed up than their employees...

For this survey, an international sample of employed adults aged 18-64 in the U.S. and Canada, and aged 16-64 in all other countries, were interviewed. The unweighted base of employed adults was 12,691 and the weighted base was 8,090. The 24 countries included Argentina, Australia, Belgium, Brazil, Canada, China, France, Germany, Great Britain, Hungary, India, Indonesia, Italy, Japan, Mexico, Poland, Russia, Saudi Arabia, South Africa, South Korea, Spain, Sweden, Turkey and the United States.

% Total Wear a Type of Uniform



% Total Business/Smart Dressing



% Total Casual Dress Anytime



% Yes Casual Wear "Designated" Time





% Total Agree Workplace/Business Attire More Productive



Only One Quarter (24%) of Workers Say it's Appropriate to Wear Shorts to Work...





Only Four in Ten (37%) Workers Say Casual Workers in Their Workplace Will <u>Never</u> Make it into Senior Management


% Total Agree Casual Dressers In My Workplace Will Never Make It Into Senior Management

Only One in Five (20%) Think Casual Dressers in Their Workplace are Slackers...


% Total Agree Casual Dressers In My Workplace Are Slackers

% Total Agree If Workers Have A Day At A Beach Or Picnic, Speedo Or Bikini Bathing Suits Are Appropriate Wear By Employees



METHODOLOGY

This @dvisory report contains data from the tenth wave of the Ipsos Global @dvisor Omnibus, an online survey of citizenconsumers across 24 countries. For this survey, an international sample of employed adults aged 18-64 in the U.S. and Canada, and aged 16-64 in all other countries, were interviewed. Unweighted base of employed adults 12,691: Argentina 327, Australia 576, Belgium 285, Brazil 676, Canada 699, China 860, France 602, Germany, 718, Great Britain 658, Hungary 487, India 904, Indonesia 416, Italy 622, Japan 643, Mexico 382, Poland 333, Russia 451, Saudi Arabia 304, South Africa 446, South Korea 358, Spain 608, Sweden 340, Turkey 335, United States 661. Weighted base of employed adults 8,090: Argentina 302, Australia 304, Belgium 291, Brazil 338, Canada 344, China 406, France 314, Germany 359, Great Britain 333, Hungary 238, India 422, Indonesia 421, Italy 317, Japan 318, Mexico 327, Poland 326, Russia 443, Saudi Arabia 229, South Africa 395, South Korea 351, Spain 306, Sweden 343, Turkey 333, United States 331. A survey with an unweighted probability sample of 1000 and a 100% response rate would have an estimated margin of error of +/-3.1 percentage points 19 times out of 20 per country of what the results would have been had the entire population of adults in that country had been polled.
