






[Overall, globalization is a good thing for the world] Do you strongly agree, somewhat agree, somewhat disagree, or strongly disagree with each of the following statements...






[Expanding trade is a good thing] Do you strongly agree, somewhat agree, somewhat disagree, or strongly disagree with each of the following statements...



Only Four in Ten (39%) Say Restrict Investment By Foreign Companies in Their Country Even if it Means Fewer Jobs Will Be Created...





Seven in Ten (69%) Believe Large Companies are More Powerful Than Government...









Only 1/3rd (35%) Believe CEO's Of Large Companies Can Generally be Trusted to Tell The Truth in Statements About Their Company or Industry...





Three Quarters (75%) Believe Their Government Should be More Aggressive Regulating Activities of National/Multinational Corporations...




