As you may know, in 2008, the City of Toronto began charging a municipal Land Transfer Tax on homebuyers when they purchase a home, in addition to the provincial land transfer tax charged by the Province. For the average Toronto homebuyer, the Toronto Land Transfer Tax amounts to about \$7,000 payable in full when a home is purchased. Mayor Rob Ford's election platform included a commitment to repeal the Toronto Land Transfer Tax. However, a recent court ruling has ordered that Mayor Ford be removed from office, and it is slated to take effect shortly. Mayor Ford is appealing the decision and may ultimately remain in office. However, if his appeal is not successful and Mayor Ford is replaced by a new Mayor as a result of a by-election or a Council appointment, to what extent would you support or oppose the new Mayor and City Council moving forward with a plan to repeal the Toronto Land Transfer Tax?
