

Canadians on the Move: Measuring Opinions of Career Mobility Among Canadians





Methodology

These are some of the findings of an Ipsos Reid poll conducted between March 18th to 20th, 2014, on behalf of the Canadian Employee Relocation Council (CERC).

For this survey, a sample of 2,008 adults from Ipsos' Canadian online panel was interviewed online. The employment distribution breaks down as follows:

- •Employed Canadians n = 1,140
- •Canadians employed full-time n=817
- •Canadians employed part-time n=323
- •Unemployed Canadians n=356

Weighting was then employed to balance demographics to ensure that the sample's composition reflects that of the adult population according to Census data and to provide results intended to approximate the sample universe.

The precision of Ipsos online polls is measured using a Bayesian credibility interval. In this case, the survey is considered accurate to within +/- 2.5 percentage points had all Canadians been surveyed. The precision of the employment sub-groups breaks down as follows:

- Employed Canadians +/- 3.3 percentage points
- Canadians employed full-time +/- 3.9 percentage points
- Canadians employed part-time +/- 6.2 percentage points
- Unemployed Canadians +/- 5.9 percentage points


All sample surveys and polls may be subject to other sources of error, including, but not limited to coverage error and measurement error.



AT A GLANCE



About half of Canadians would consider relocating for a full time job in their current (54%) or outside (45%) province— and half (54%) would do likewise for a short-term job with their employer in another province ... Other Canadians would consider a full time contract job in their province (42%) or in another (35%)...




Q1. Imagine if you had a job opportunity in the near future that would mean relocating. How willing would you be to take it based on the following:



For consideration of all three types of short-term work positions the top two incentives of all those tested are temporary accommodations and expenses, and round-trip tickets to return to their home city...





Respondents who would consider a relocation job were asked to select the top government incentive that could be provided for each of the five types of relocation options. 4,136 mentions were counted. This scorecard represents the percentage of mentions each incentive received across all five options.


















